Securing or Terminating Care Over the Summer Closure: Parents have the choice to keep their child's space secured at TSCC over the summer closure dates by simply paying the educators paid accrued vacation time and not withdrawing from their childcare contracts. If parents, choose to withdraw from their childcare contracts for the summer then their childcare contracts are effectively terminated, and their child's spaces will NOT be secure. In these cases, parents take the chance that any vacant spaces may be filled at anytime and TSCC is able to sign new childcare contracts with perspective clients for these spaces. Parents that wish to withdraw childcare for the summer are subject to all policies regarding termination of care as outlined in TSCC's handbook, policies, and contracts.

<u>Paid Vacation/ Earned Banked Time Off:</u> Additionally, there are 260 billable childcare days in 2023. Parents are billed based on 20 billable days per month for a total of 240 per year. The 20 days not billed for are allocated towards the educators paid vacation time. Therefor the educator has worked for this vacation time and parents should realize that payment during vacation closures has been earned.
